Over 115 members attended the meeting to learn about the current status

of the Illinois pension systems and how they are faring amid the State's current financial crisis.

SIU chapter president, Bob Radtke, and SUAA Executive Director, Linda Brookhart, welcomed the group followed by morning sessions that included speakers from SUAA's state office, SURS, and the Illinois Retirement Security Initiative.

For lunch, attendees enjoyed the Lodge's famous family-style chicken dinner with all the trimmings. The afternoon session included local state legislators, Representative Mike Bost (R-115, Carbondale) and Senator Dave Luechtefeld (R-58, Okawville), addressing the group. An active question and answer period followed their talks.

# President's Message

# Jreetings,

The past few months have been a busy time for your SIUC EAA Board of Directors. It began at the end of August when I gave the EAA talk at the annual banquet honoring retirees and employees with long years of service. I touted the importance and the benefits of SUAA and our local EAA, and encouraged their participation with us in protecting our retirement benefits. To what success? I do not know.

Chancellor Rita Cheng visited our September Board meeting to get a first- hand account of our purpose, goals, and activities, as well as to update us on current issues facing the university. It was an informative visit from both sides. It is encouraging to see the Chancellor take such interest in who we are and what we

are about. Vice Chancellor Ricky McCurry was also in attendance to inform us of changes in the Office of Constituent Relations and Special Events that will affect our organization and to offer his advice.

This was followed by our September 24 Regional SUAA meeting at Giant City Lodge. It was good to see so many of our SIUC members there as well as representatives from other colleges and universities in Southern Illinois. There were a total of 115 people in attendance. The theme of the meeting was *Surviving the Illinois Fiscal Crisis*, and in the morning we heard speakers from the Illinois Retirement Security Initiative (of which SUAA is member), the Vice Chair of the SURS Board, the SUAA Executive Director, and the SUAA contract lobbyist. I won't recount the dire warnings about the budget crisis and the potential impact on our retirement benefits, but the message was clear: SUAA must remain vigilant and politically active, and that means not only our paid staff, but each and every one of our members. And there was the frequently heard but nevertheless important encouragement to enhance our influence by increasing our membership numbers. After a delicious Giant City fried chicken with all the trimmings lunch, we reconvened to hear our two local legislators, State Senator David Luechtefeld and State Representative Mike

Bost. There followed a lively hour-and-a-half question and answer session with our representatives and SUAA staff members. All in all, I think it was a very successful and informative regional meeting, and one which we are likely to repeat in the future.

There followed the October meeting of the SUAA Board of Directors in Champaign at which Bruce Appleby and I were in attendance. We heard an interesting presentation from State Representative, Chapin Rose, on his ideas on how to get out of the state's budget hole. The focus of the meeting was again on state budget issues, the presentation and discussion of an SUAA legislative program for 2011, and the persisting problem of members who do not renew their membership. I was also appointed to the Executive Committee of the SUAA Foundation, to replace Emil Spees. More about that later.

By the time you read this, the election will be over. Let us hope the legislature and governor will now have the political courage to work together to solve the budget mess and keep their promises to retirees.

## October SUAA Board of Directors Meeting

The SUAA Board of Directors met in Champaign on October 5. Aside from the ongoing concerns about the state's budget crisis and legislative attacks on the state pension systems, there were three main topics of discussion. The first concerned SURS. Exec. Dir. Bill Mabe, reported that in spite of reports in Chicago newspapers, SURS benefits are not overly generous; 65% of SURS benefit

recipients receive \$2600 or less per month. Cost to the state for SURS is approximately 3.74% of employee pay. The current SURS funding ration is 48.6%. If the state does not make its certified contributions to the pension systems this year, SURS will be forced to liquidate \$1.3 billion from its investment portfolio to pay benefits. SURS and SUAA support the issuance of public bonds to provide the state's FY 11 certified contributions to pension systems. Fred Giertz, SURS Board member, spoke on pension sustainability and indicated the number of retirees is growing faster than the number of employees forcing SURS to sell more assets than they would like. While SURS is secure, he emphasized that it depends critically on the state continuing to make its mandated payments into the system.

The second topic was the proposed SUAA legislative program for 2011. That proposal is still being "tweeked", but the main points are (1) to continue to fight against the efforts to diminish the benefits of current employees instigated by Eden Martin et al of the Civic Federation and Commercial Club of Chicago, and to fight for the plain meaning of the Illinois Constitution which states: "Membership in any retirement system of the state, any unit of local government or school district or any agency or instrumentality thereof, shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired." (2) To encourage amendatory legislation to revise the recently passed pension changes for new employees. (3) To support revenue enhancement by increasing personal income and corporate tax rates. Any revenue increases should go toward debt reduction. There should be a moratorium on new state spending programs, and short-term borrowing should be phased out. (4) To support SURS in its continuing effort to make sure the pension system is funded, not only at the normal costs, but at the levels legislated to retire the pension debt. There are other aspects of the proposal, but these are the main points as I see them.

The third major topic focused on membership and various strategies for recruiting new members and re-enrolling members who have dropped their membership.

# Sharlet Smith retires October 31.

Sharlet Johnson Smith, long-term SIUC staff member and Program Administrative Assistant in the Constituents Relations and Special Events Office, recently retired with over 30 years of service. Shar, as she is known around campus, has provided office support services to the Emeritus and Annuitant Association for many years and has been our 'go-to' person in planning and coordinating many of our functions. We will certainly miss her and her efficiency in handling our many needs.

In talking with Shar about her years at the university, we uncovered an interesting work background her 30 plus years afforded her. To recapture some of her many experiences, we go back to the year 1969 when she took her first position with SIU. She related how things have changed since then and recalled that in her early years promotions caused her to change jobs each year.

Having worked in several departments over the years, she shared some of her favorite memories. First on her list was the SIUC Airport, where she kept track of the hours students flew, etc., and then moved to the Airport parts department where she gave parts to the mechanics and kept inventory. Shar recalls, "I loved the open windows of the terminal. Great for watching storm clouds gather and lightening flash while the "weather boy" Randy Patchett, then a SIUC student, entered data for local weather stations. It was cool to watch and listen to Randy's "live" radio weather updates." She went on to say, "The most fun I had at the airport, however, was volunteering to go on each test fly! After the mechanics worked on a plane they had to do a test fly. If the plane was a four-seater, they needed four bodies on the plane. They knew I was always ready and eager. One morning, a student had to take his instructor's exam so that he could start teaching. I didn't know that one of the maneuvers would be a stall. When the engine stopped and the plane began to drift backward into a kind of slow downward spin, I yelled, 'is this supposed to happen?' Not until after the student successfully brought the plane back to life and leveled it off, did the instructor calmly answer, 'Yes, that was supposed to happen.'" She recalls that three people snickered, and one guess which person wasn't amused.

Another transfer found her working for head football coach, Dick Towers, who held that position for seven seasons, from 1967

until 1973. Shar remembers that winning seasons always bring excitement...especially when you personally know the players AND know which plays they plan to run and described those times as, "Wow. Pure joy!" Coach Towers assigned a special "safe" area for the ladies of the office to exercise. The boys were like brothers. They teased and played "jokes" on each other as well as on staff members. Lionel Antoine was one of the most famous players at the time. Later a promotion moved Shar to a new position under Jack Dyer and Dorothy McCombs. University Relations is now known as Constituent Relations and Special Events. When President Clinton came to Campus, she was one of many to work with the men in black (Secret Service). "Wow. How cool is that?" Shar exclaimed.

Though the department has gone through many transformations, the SIUC Emeritus Association has remained a constant element of CRSE. Over the 32 years with SIUC, Shar reflected that, "I've met many wonderful people and found great friends. And, yeah, this pony has been around the track a few times!" *Congratulations, Shar, on your latest well deserved promotion - your retirement.*

George Waring, Professor Emeritus of Zoology, will deliver the 2010 Emeritus Faculty Lecture. The lecture is scheduled for November 30, 7:00 PM at the Law School Auditorium. During his lecture titled "Pursuing the Birds of China," Professor Waring will show habitats plus examples of numerous beautiful and unusual birds occurring in mainland China. He has been on two 3-week birding trips to China to explore such provinces as Shaanxi, Sichaun, Yunnan, Guanxi, Fujian, and Jiangxi. He will discuss the amazing diversity of avifauna in that country and show examples of some of the cranes, sunbirds, minivets, parrotbills, forktails, fulvettas, yuhinas, prinias, barbets, and other species he saw. Besides visiting China, Dr. Waring has observed free-ranging vertebrate animals in their natural habitats worldwide, including those occurring in 70 other countries.

Admission is free and all are welcome to attend.


